Adopt June 2019 Minutes (Taken by Paula Lupcho in Diana's absence)

Officer Reports

Vice President – BCMGA Programs Debbie Lauer

- o Garden tour went off without a hitch, dispute the heat!
- Tour to the Herbarium also had a great turnout.
- Annual Picnic on September 16th Philomath Park on Applegate St, from 5-9:00.
 Dale was able to reserve the place for no cost!

President Elect – Nominating Committee, auction gifts Nancy Tovar

- Starting on nominations for next year's board. Debbie Wray has offered to assist on the nomination committee. Open positions are: Vice-president, president-elect and membership.
- Marge Alig suggested possibly adding a treasurer co-chair position due to the complexity of the job description.
- Discussion on ways to encourage the participation of new trainees in MG activities, including serving on the BCMGA Board.
- Auction gifts OMGA
 - Silent auction to be held Nov. 1-2 during the OMGA Leadership Forum and Board of Director Meeting. (This fundraiser replaces the silent auction usually held during Mini-College.)
 - Requesting at least three auction items valued by at least \$25 each.
 - This will be an online auction details on bidding at a later date.

Treasurer – Financials, CD discussion Marge Alig

• Marge Alig reviewed June financial statements with the board. Minor changes to be updated and sent out with the July minutes.

- Marge Alig reviewed a proposal for the addition of a third CD:
 - Addition of \$30,000 to the Greenhouse Capital Fund, followed by opening of a new \$30,000 12-month CD at First Internet Bank of Indiana, using the new dedicated Greenhouse Capital Funds.
 - Rationale: The BCMGA checkbook balance as of May 31, 2019 was \$100,380.46. Conservative estimates of expenses and revenues through December 31, 2019 leave us with a projected checkbook balance of approximately \$75,000. A \$30,000 CD purchase results in a checkbook balance of at least \$45,000 to begin the next budget year
 - The Greenhouse Committee meets next week and will have an update for the next Board meeting on actual costs for purchasing a greenhouse.
 - Jennifer Klammer and Debbie Wray met with the BC Fairgrounds Director (Lynn McKee) regarding a possible greenhouse site on the BC fairground property. Lynn McKee was reportedly excited about the possibility of working with the BCMGA.
 - Motion: The BCMGA Board authorizes the Treasurers to revise the 2019 BCMGA budget by adding \$30,000 to the Greenhouse Capital Fund, and to use those funds to facilitate creation of a new 12-month \$30,000 CD at First Internet Bank of Indiana (FIB) in early July 2019.
 - ☐ It was moved, seconded and approved to authorize an additional \$30,000 for the Greenhouse Capital Fund.

OMGA Rich Taylor

- o Rich provided an update from the June 7, 2019 OMGA Leadership Forum:
 - Presentation by Kara Baylog on fire resistant plants
 - o PNW 590 is a good publication for selecting fire resistant plants
- OMGA Board meeting on June 8, 2019:
 - There is a Treasurer's workshop at the LC Extension Office from 10-12:00 PM.
 The goal is to get all county MG programs using Quickbooks. Also encouraging treasurers to have a separate e-mail account to pass on to new treasurers.
 - Response to OMGA Survey.
- BCMGA Website Options:
 - Currently using the website through OSU
 - Judith and Rich Taylor met with Elizabeth Records to go over the website and possible editing resources. We are limited in our ability to edit and Elizabeth and Brooke are investigating getting us more privileges. Not going to happen.
 - Rich reviewed what other MG Chapters are using for their websites.
 - Reviewed Jackson (Word Press), Lincoln (WIX) and Yamhill counties websites.
 - Laurel Briggs of CM&D provided a rough estimate of developing a new website for BCMGA:

- \$3000 to develop the new website
- \$300 for annual hosting fee
- Annual renewal fee for \$15.
- Rich developed a small BCMGA "demo" website using WIX for our preview.
- Rich is forming an ad hoc committee to review options for developing a BCMGA website. Initial members include: Nancy Tovar, David Dowrie, Judith Kenner and David Mandel
